Privacy Policy

Thank you for visiting www.jabocomm.com, which is owned and operated by Jabo Communications. This privacy policy tells you how we use personal information collected at this site. Please read this privacy policy before using the site or submitting any personal information. By using the site, you are accepting the practices described in this privacy policy. These practices may be changed, but any changes will be posted and changes will only apply to activities and information on a going forward, not retroactive basis. Collection and Use of Information

In general, you can visit our site without telling us who you are. This may involve sharing certain information with affiliated companies or third parties, for instance to fulfill orders. You further agree that the information you provide is current, accurate and complete and that you will update it if there are any changes.

Our web servers may collect the domain names or IP addresses of visitors to our site. This information may be aggregated to measure the number of visits, average time spent on the site, pages viewed, etc. We may use this information to measure the use of our site and to improve the content we offer. We may share with third parties this experiential information or other data which does not personally identify visitors to our site.

Cookie/Tracking Technology

The Site may use cookie and tracking technology depending on the features offered. We do not sell personal information to third parties but we may share your information with our affiliated companies or with third parties if: (1) you request or authorize it; (2) the information is provided to help complete a transaction for you; (3) the information is provided to comply with the law, applicable regulations, governmental and quasi-governmental requests, court orders or subpoenas, to enforce our Acceptable Use Policy or other agreements, or to protect our rights, property or safety or the rights, property or safety of our users or others (e.g., to a consumer reporting agency for fraud protection etc.); (4) the disclosure is done as part of a purchase, transfer or sale of services or assets (e.g., in the event that substantially all of our assets are acquired by another party, customer information may be one of the transferred assets); (5) the information is provided to our agents, outside vendors or service providers to perform functions on our behalf (e.g., analyzing data, providing marketing assistance, providing customer service, processing orders, sending emails about our products or services, etc.); or (6) as otherwise described in this Privacy Policy. We may also gather aggregated data about you and disclose such aggregated (but not personally identifiable) information to third parties for promotional or other purposes.

Commitment to Data Security

We have adopted administrative, physical and technical protocols to protect information that we collect. We do not use security technology to encrypt information you provide to us through the Site because we generally only collect contact information.
