## Privacy Policy

Thank you for visiting [www.jabocomm.com](http://www.jabocomm.com), which is owned and operated by Jabo Communications. This privacy policy tells you how we use personal information collected at this site. Please read this privacy policy before using the site or submitting any personal information. By using the site, you are accepting the practices described in this privacy policy. These practices may be changed, but any changes will be posted and changes will only apply to activities and information on a going forward, not retroactive basis. You are encouraged to review the privacy policy whenever you visit the site to make sure that you understand how any personal information you provide will be used.

### **Collection and Use of Information**

In general, you can visit our site without telling us who you are. If you wish to obtain information, request a quote, become a business partner or inquire about jobs with us we will ask for identifying information about you. We may collect your name, postal address, email address, telephone or fax number and other information about you or your company that you voluntarily provide. Prospective employees can upload their resumes through our Career page.

By providing this information you explicitly agree to our collection and use of the information as described in this privacy policy. You agree that we may use the personal information you provide for our general commercial purposes including to respond to your inquiries, process orders, contact you regarding customer service, let you know about products or services (including those of third parties) which may be of interest to you or to personalize our service to meet your needs or preferences. This may involve sharing certain information with affiliated companies or third parties, for instance to fulfill orders. You also agree that we may share your personal information with our affiliated companies and third parties as described in this Privacy Policy. You further agree that the information you provide is current, accurate and complete and that you will update it if there are any changes.

Our web servers may collect the domain names or IP addresses of visitors to our site. This information may be aggregated to measure the number of visits, average time spent on the site, pages viewed, etc. We may use this information to measure the use of our site and to improve the content we offer. We may share with third parties this experiential information or other data which does not personally identify visitors to our site.

### **Cookie/Tracking Technology**

The Site may use cookie and tracking technology depending on the features offered. Cookie and tracking technology are useful for gathering information such as browser type and operating system, tracking the number of visitors to the Site, and understanding how visitors use the Site. Cookies can also help customize the Site for visitors. Personal information cannot be collected via cookies and other tracking technology, however, if you previously provided personally identifiable information, cookies may be tied to such information. Some cookies are deleted once you leave our Site ("session cookies"), while other cookies remain after you leave our site ("persistent cookies") so that you are recognized when you return to the Site.

You also have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of our website or have some of our services, such as planning a cruise, making a reservation, or being automatically recognized as a registered user, function properly. Aggregate cookie and tracking information may be shared with third parties.

### **Child Privacy**

Because of the nature of our business, our products and services are not designed to appeal to minors, and therefore we do not knowingly attempt to solicit or receive any information from children under 18. If we have reason to believe that information is being provided by a person under the age of 18 we will not collect the information. By providing information about minor passengers you agree that you are the minor's parent, legal guardian or parentally authorized adult.

### **Distribution of Information**

We do not share your information with third parties for their marketing purposes. We do not sell personal information to third parties but we may share your information with our affiliated companies or with third parties if: (1) you request or authorize it; (2) the information is provided to help complete a transaction for you; (3) the information is provided to comply with the law, applicable regulations, governmental and quasi-governmental requests, court orders or subpoenas, to enforce our Acceptable Use Policy or other agreements, or to protect our rights, property or safety or the rights, property or safety of our users or others (e.g., to a consumer reporting agency for fraud protection etc.); (4) the disclosure is done as part of a purchase, transfer or sale of services or assets (e.g., in the event that substantially all of our assets are acquired by another party, customer information may be one of the transferred assets); (5) the information is provided to our agents, outside vendors or service providers to perform functions on our behalf (e.g., analyzing data, providing marketing assistance, providing customer service, processing orders, sending emails about our products or services, etc.); or (6) as otherwise described in this Privacy Policy. We may also gather aggregated data about you and disclose such aggregated (but not personally identifiable) information to third parties for promotional or other purposes.

#### **Commitment to Data Security**

We have adopted administrative, physical and technical protocols to protect information that we collect. We do not use security technology to encrypt information you provide to us through the Site because we generally only collect contact information. You can provide your information or make requests securely by contacting us in writing or by fax, please see below.

#### **Access to Your Information**

You can direct us to delete your email address from our mailing list simply by following the instructions on any email you receive.
